

## Vincent Park – Bringing Green to Our Mall Art Competition

### COMPETITION TERMS AND CONDITIONS:

1. The competition is conducted by Excellerate Brand Management (Pty) Limited; (registration number: 2013/068414/07) on behalf of Vincent Park (registration number: 2012/150042/07) (“the Promoter”).
2. The competition can only be entered into by persons who are currently in Grade 7 or below. Entrants must be SA Citizens and must reside in the greater Buffalo City municipal area. A minor who enters the competition undertakes that he/she does so with his/her parent’s/legal guardian’s consent.
3. No director, member, partner, employee, agent, consultant, promoter, supplier or anybody directly or indirectly involved in this competition and any spouse, life partner, immediate family member, business partner or associate of such person is allowed to participate.
4. The competition runs from 12 March 2020 to 6 April 2020. Completed entries must be handed in at the Vincent Park Information Desk. No late entries will be accepted.
5. To enter the competition participants need draw or colour a unique design onto the competition template. Only designs completed on an official entry template will be eligible. The completed entry form must include the following information:
  - a. Child’s name + Surname
  - b. Age (as at 30 April 2020)
  - c. Parent / Guardian’s details and contact number
  - d. School / Art School
6. All of the eligible entries will be displayed in Vincent Park Shopping Centre. Members of the public will vote for their favourite design via SMS from 08:00 on 8 April to 24:00 on 13 April 2020. All eligible entries will be allocated a unique number. Members of the public will be required to SMS the unique number to the designated competition number during the voting period. The winner will be the entry with the most votes. In the event of a tie, the judges reserve the right to make the final decision. The judges’ decision is final.
7. The prize consists of one R2500 (two thousand five hundred Rands) Vincent Park gift card for the winning design and one R2500 (two thousand five hundred Rands) Vincent Park gift card for the nominated school / organisation. The winning design will also be transferred to a mural painting which will be unveiled and on public display in Vincent Park from 22 April 2020. No further claims for imbursement will be considered.
8. The prize-winner will be notified by e-mail or telephone, by no later than Wednesday, 22 April 2020.

The prizes are not transferable, exchangeable or redeemable for cash unless the Promoter cannot provide the prize(s) for whatever reason, in which case the prize(s) offered, at the discretion of the Promoter, will be of equal monetary value to the initial prize(s).
